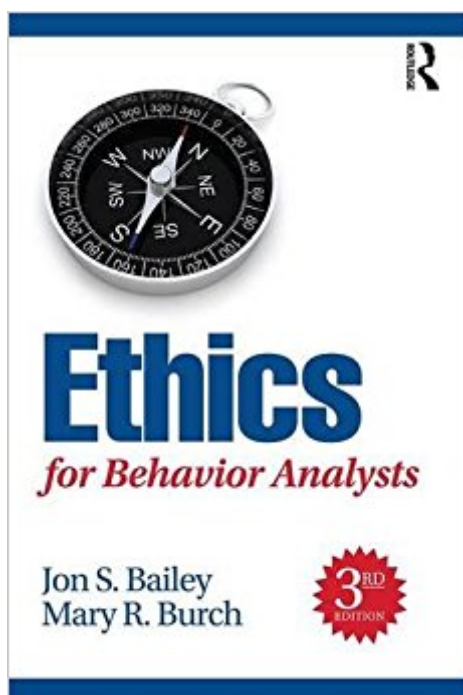

If you are in an ABA program this will probably already be a book for your ethics class but even if not it goes over all the ethical compliance coded thoroughly and easily to understand. It also has scenarios to which you can apply these ethical codes test yourself. I had it for a course but decided to keep it as a resource as opposed to selling it or renting it.
