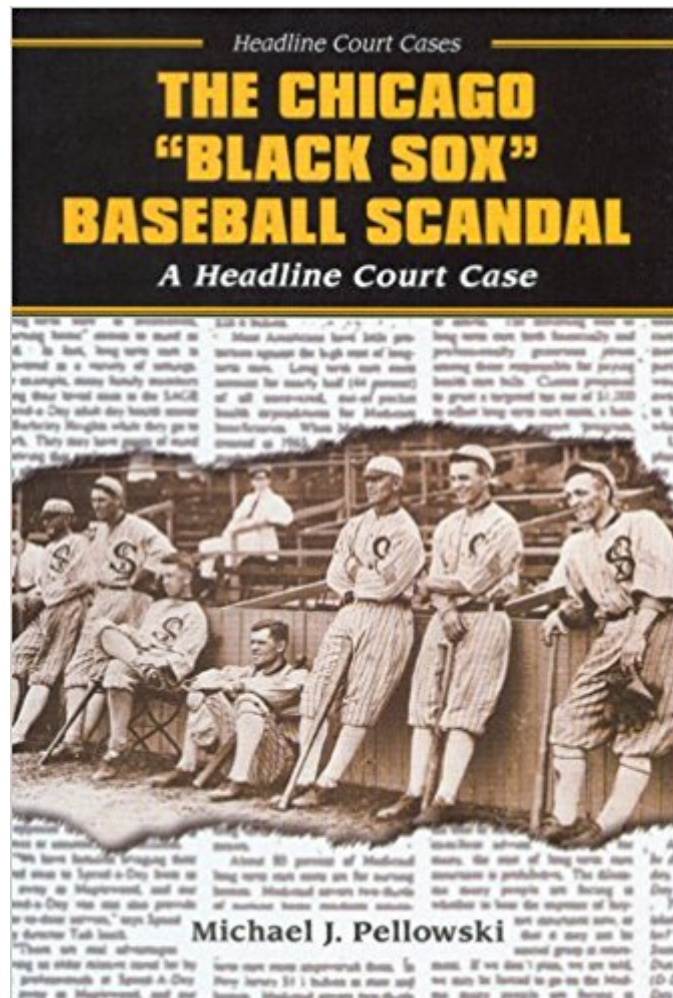

Grade 7 Up-The fix of the 1919 World Series, in which eight members of the Chicago White Sox were alleged to have lost purposely to the Cincinnati Reds, is considered by many to be the "biggest scandal in baseball history," and sparked the legendary line, "Say it ain't so, Joe." While the attempts at replicating period newspaper design are weak, the facts are solid, and the index and chapter notes are thorough. The glossary is standard, but the author does a fine job of explaining some possibly unclear legal and athletic terms in context. Following chapters that provide the necessary background information, each game in the series is given attention with lineups and individual plays described. When the betting becomes widely known, the author follows the subsequent legal process from assistant district attorney to grand jury to civil court to the players' banishment from professional baseball, as well as the influence of the media at each of these steps. Frequently, the text becomes a jumble of player, management, lawyer, and gangster names as an attempt is made to include the myriad aspects of a complex situation. Many of these lives are followed to their end to demonstrate the effect of this case not only on the public and the sport, but on individuals. Pellowski presents a balanced case, and readers are encouraged to consider their own conclusions based on available details. Eight good discussion questions are included. A
