

# Death At SeaWorld: Shamu And The Dark Side Of Killer Whales In Captivity



## Synopsis

From the New York Times bestselling author of *Evidence of Harm* and *Animal Factory* – a groundbreaking scientific thriller that exposes the dark side of SeaWorld, America's most beloved marine mammal park. *Death at SeaWorld* centers on the battle with the multimillion-dollar marine park industry over the controversial and even lethal ramifications of keeping killer whales in captivity. Following the story of marine biologist and animal advocate at the Humane Society of the US, Naomi Rose, Kirby tells the gripping story of the two-decade fight against PR-savvy SeaWorld, which came to a head with the tragic death of trainer Dawn Brancheau in 2010. Kirby puts that horrific animal-on-human attack in context. Brancheau's death was the most publicized among several brutal attacks that have occurred at SeaWorld and other marine mammal theme parks. *Death at SeaWorld* introduces real people taking part in this debate, from former trainers turned animal rights activists to the men and women that champion SeaWorld and the captivity of whales. In section two the orcas act out. And as the story progresses and orca attacks on trainers become increasingly violent, the warnings of Naomi Rose and other scientists fall on deaf ears, only to be realized with the death of Dawn Brancheau. Finally he covers the media backlash, the eyewitnesses who come forward to challenge SeaWorld's glossy image, and the groundbreaking OSHA case that challenges the very idea of keeping killer whales in captivity and may spell the end of having trainers in the water with the ocean's top predators. I just finished this book. While I'm an avid reader of anything orca, I still wanted to read this book, even though I knew it would be much of the same info I've already read. And it was. It was heavier in the science than I'd expected, so that was interesting.

It uses decades of scientific field research to explain why whales in captivity are lonely, broken, and living only half the number of years as orcas in the wild. It has interviews with not only whale researchers, but also former Sea World trainers from around the globe. It reminded me that Sea World, at its core, is a multi-billion dollar entertainment business. You'll learn why whales collected from around the world do not make a pod, and so much more including how Sea World knew the danger to the trainers before the deaths that occurred. Yes, deathS, plural.

This book uncovers the trade behind keeping killer whales in captivity. The main reason it's done is for profit. Yes, it can be argued that captivity has helped us learn much about this species. However, we have also learned captivity makes these magnificent creatures neurotic and cuts their lives short. The time for retiring these animals to sea pens has arrived. Establishments, like sea world can charge folks to view these creatures in their sea pens. If Sea World is really a company concerned with conservation, this would be the way to go. If the industry continues the way it's going, there will

be more trainer deaths and injuries. Make no mistake, it's not a question of if, it's a question of when.

I loved this book. After reading this there is just no way I can support killer whales in captivity. The book highlighted so many things about killer whales such as their bonds, feeding habits and general lifestyles that I had no idea about previously. I can't look at Sea World the same anymore after reading this book. I don't feel that the author led you to believe that Sea World is manipulative etc.. I think he presented the facts of both sides evenly. I don't see how you can look at a killer whale in captivity and think that they are happy and content. It took me a month or so to read this book but not because it was "slow" but because I really wanted to comprehend everything that I was reading. And frankly, sometimes the subject matter depressed me and I would have to step away for a bit. It's hard to think that we, as humans, are doing this to these amazing creatures. I would definitely recommend this book!

This book documents not only the deaths of SeaWorld trainers (yes, more than the 2010 death of Dawn Brancheau that we're familiar with), but also the deaths and various maladies of the whales. The author makes a strong case against keeping these intelligent, ocean-going mammals in small pools and training them to perform in "Shamu" shows. Although I found the book to be extremely interesting at first, I felt that it dragged on too long. I also felt that the ending was unsatisfactory, ending in the middle of an OSHA v. SeaWorld hearing without revealing the outcome. After finishing the book, I checked on Google, and apparently the hearing is still going on due to the many appeals by SeaWorld. Still, I believe that the book ended too abruptly, and that the author should have given some indication that the outcome of the hearing was still to be resolved.
